The Mississippi Legislature during the 2008 Regular Legislative Session passed Senate Bill 2979, which amends Miss. Code Ann. §§ 83-5-73, 83-5-75, and 83-5-77 to increase certain fees paid by licensed insurance companies for certain services provided by the Mississippi Department of Insurance. This Bulletin has been prepared to advise companies of the new fee amounts as established by Senate Bill 2979.


