**VOLUNTARY SURRENDER OF LICENSE
AND CONSENT TO ADMINISTRATIVE PENALTY**

I, **DAVID WOOD D/B/A WOOD MOBILE HOME CONTRACTORS**, having been fully informed of my alleged noncompliance with *Miss. Code § 75-49-1 et. seq. (The Uniform Standards Code for Factory-Built Homes Law)* as a result of the actions alleged in the Notice of Hearing and Statement of Charges issued by the Mississippi Insurance Department dated March 16, 2016, receipt of a copy of which I hereby acknowledge, and understanding that I am entitled to a hearing before the Commissioner of Insurance of the State of Mississippi to determine the reasonableness of the Commissioner's action, do hereby consent, in lieu of such hearing, to the following terms and conditions:

- (1) David Wood d/b/a Wood Mobile Home Contractors does hereby voluntarily surrender Installer/Transporter License No. 15025009, to act as an Installer/Transporter of factory-built homes in the State of Mississippi, effective immediately.
- (2) David Wood d/b/a Wood Mobile Home Contractors agrees to cease and refrain from engaging in the transportation or installation of factory-built homes within the State of Mississippi, until such time as he obtains a license from the Commissioner of Insurance for the State of Mississippi as required by Miss. Code § 75-49-9, and it is understood that engaging in such conduct without first obtaining an appropriate license will constitute a criminal violation of Miss. Code § 75-49-19(4).
- (3) David Wood d/b/a Wood Mobile Home Contractors further agrees that he is indebted to the Mississippi Insurance Department for delinquent inspection fees, in the total amount of Four Thousand Eight Hundred Dollars (\$4,800), which is now due and payable.
- (4) David Wood d/b/a Wood Mobile Home Contractors further consents and agrees that he be, and hereby is, assessed an Administrative Fine in the amount of Five Hundred Dollars (\$500), payable to the Mississippi Insurance Department.

This Consent to Administrative Penalty is being tendered in lieu of other possible administrative action by the Office of the State Fire Marshal, a division of the Mississippi Insurance Department.

I fully understand that should I fail to follow the terms of this Consent to Administrative Penalty as agreed, that an administrative hearing may be set by the Commissioner of Insurance and administrative action may be taken against me as provided in the Mississippi Code.
